Sub: Activation of Online application form for DDU-GKY Project Proposal Submission

In continuation to Notification no 28/2015 dated 15.6.2015, it is hereby stated that the Online Project Application Form under DDU-GKY (including Roshni initiative) is available at website: www.ddugky.gov.in. All registered organizations with valid Permanent Registration Numbers (PRN) shall be required to file their project applications online. The online application is mandatory for obtaining new projects in both Action Plan States (AP States) and Year Programme States (YP States).

- 2. An organization with a valid Permanent Registration Number (PRN) may apply for a project with its user credentials (Username and Password) that has been made available to the organization along with the PRN. User manual for submission of Online Project Application is available under "Resources" tab at www.ddugky.gov.in.
- 3. Application may now be called for by all AP states in the notified Online Application Format. The current AP states are Andhra Pradesh, Bihar, Gujarat, Karnataka, Kerala, Maharashtra, Odisha, Punjab, Rajasthan, Tamil Nadu, Telangana and Uttar Pradesh.
- 4. With regard to YP states, applications shall be accepted for all states, but shall be processed only for North East states. Application submitted for other YP states shall be processed as and when unassigned targets become available in such states.

5. With effect from the date of notification, a non-refundable application processing fee shall be charged as given below.

Application type a) All applications for DDU-GKY projects in YP states	Application processing fee Rs. 25,000
b) All applications for Roshni projects	Rs.25,000
c) All applications for DDU-GKY projects in AP states	Rs.25,000, or a fee as notified by the concerned AP state.

6. It is further stated that the Ministry shall separately notify an e-payment procedure for project application fees. Till such time, project application fees shall be paid by all project applicants using RTGS / NEFT into the bank account as given below:

- 7. Application fee is non-refundable in any or all circumstances. It is also stated that submission of project application fee does not guarantee sanction of a project. The sanction of project is subject to fulfilment of DDU-GKY Guidelines, appraisal processes, and notifications issued by the Ministry from time to time.
- 8. For any technical support or complaint regarding the online project application, any State government agency implementing DDU-GKY or any registered organization with a valid PRN, may register a query/complaint/Grievance at the Help Desk available at http://ruralskills.in:4040/trac/MrigsSSP. Complaints/Queries/Grievances of the applicant organizations shall not be entertained in person in the Rural Skills Division, MoRD.
- 9. In case of any claims relating to application processing fee charged for project application for sanction of a project in an YP state, an appeal shall primarily lie with Joint Secretary (Skills), Ministry of Rural Development, Thapar House, New Delhi. The decision of Joint Secretary (Skills), Ministry of Rural Development shall be final.
- 10. In case of any claims relating to application processing fee charged for an application for sanction of a project in an AP State, an appeal shall primarily lie with Appellate Authority notified by the concerned State Government, whose decision shall be final. Where an Appellate Authority has not been notified, Secretary (Rural Development) in the State Government shall be the deemed Appellate Authority.
- 11. This notification is issued with the approval of the competent authority and/comes into force with effect from the date of notification.
